CALL FOR NOMINATIONS

FOR OFFICE BEARERS OF IWWA HQ FOR THE YEARS 2015-2017

As per the Rule 21 of the Memorandum & Rules of the Association the Council of Management shall have the following Office Bearers who shall be appointed under regulation 21A by the Council from Members of the Association :-

| 6) Co-opted Members | As may be decided by the Council.
(Co-opted Members shall hold office upto 31 st March of the next year after the date of his appointment. They shall be eligible for reappointment as co-opted member from time to time. |

As per rule 21A, of the Memorandum & Rules of Association, Council may appoint the above office Bearers from the members of the Association.

As per the Rule 26, the above Office Bearers shall hold Office for the term of two years with liberty to the Council to extend the period by further term of two years as the Council may in its absolute discretion deem fit and proper.

As per the rule 26(xii) the tenure of all office bearers except President and Vice President shall be for a period of two years and it will be Co-terminus with the term of the Council. In case, he is selected midway during a year, his term will also be Co-terminus with the term of the existing Council. The period shall be construed as one term.

The present Office Bearers nominated by the Council for the years 2013-2015 are completing their two years term on 31st March 2015. In the Council of Management meeting held on 24th July 2014 at Hyderabad the issue of appointment of new Office Bearers for the years 2015-2017 was discussed. It was decided to call nominations through Centres keeping 30th September 2014 as the last date for submitting the nominations. Any interested member of the Association can send his nomination for the above posts.

In view of the above decision it is requested to bring the contents of this letter to the notice of all members under your jurisdiction and send any such nomination of interested members from your Centre showing therein the post for which he/she is nominated. While sending the nominations please follow the suggested guidelines as given below :-

- 1) Centres shall send the name of the candidate with membership number proposed by at least one member and seconded by one member.
- 2) The nominations so received will be placed before the meeting of the Council of Management to be held on 11th October 2014 at Bhopal.
- 3) If the total proposals received are more than the specified posts and the appointment/selection is not possible by general consensus of the Council, the Council will decide further strategy including holding election wherein all members of the Council of Management will be the voters.
- 4) The willing members should give undertaking to the effect that he/she shall attend maximum number of Council meetings during his/her tenure.
- 5) He/She will be very sincere in discharging his responsibilities in the interest and of the objectives of IWWA
- 6) The nominations addressed to the Hon. Secretary General, IWWA, should reach to IWWA HQ Mumbai **on or before 30th September 2014 in the format enclosed.**
- 7) Members may kindly note that applications received after the said date will have to be rejected.
